

German electro and digital industry – Exports and imports


The German electro and digital industry increased its **exports** by 5.7% (year-on-year) in **June** 2023. They reached a value of €21.3bn. Thus, exports still rose, but the dynamic weakened once again.

In the **first half year of 2023**, electro exports summed up to €127.3bn, surpassing the corresponding pre-year level by 9.0%.

Regarding the **imports** of electrical and electronic products to Germany, they grew by 7.1% to ≤ 22.4 bn in June. From January through June of this year, imports soared by 11.8%, accumulating to ≤ 136.2 bn.

Although German electro exports to China showed a weak development so far this year, the People's Republic leads the list of the biggest customer countries of the German electro and digital industry in the first half of 2023 – slightly ahead of the USA. They are followed by the Netherlands, France and Italy.

Electro exports to **China** receded by 2.0% (year over year) to \notin 2.2bn in June 2023 and by 2.5% to \notin 12.5bn in the first six months of this year. In contrast, deliveries to the **USA** grew by double-digit rates in June (+10.5% to \notin 2.2bn) as well as in the first half of 2023 (+13.7% to \notin 12.5bn).

Strong increases were also recorded for exports to the **Netherlands** (ranked 3rd). They surged by 10.2% to \in 1.3bn and by 26.9% to \in 7.8bn from January through June. However, exports to **France** and **Italy** advanced more moderately. The former grew by 3.4% to \in 1.4bn in June and by 7.5% to \in 7.7bn in the first half of the year, the latter by 3.0% to \in 1.0bn and by 7.9% to \in 6.1bn, respectively.

For the first half of 2023, **Poland** holds the 6th position in the top ten customer countries of the German electro and digital industry. German electro exports worth €1.0bn (+10.8% compared to the previous year) were delivered to Poland in June 2023. In the first six months of the year, exports to Poland came to €5.8bn (+9.4%). Sector's exports to Austria grew further. They rose by +5.9% to €907m in June and by 12.9% to €5.5bn in the first half of this year.

Electro exports to the **Czech Republic** (8th position) decreased by 2.8% to €840m in June. A decline was also recorded for the first half of the year (-3.5% to €5.0bn). However, increases were reported for electro exports to **UK**. They picked up by 8.4% to €848m in June and by 8.0% to €4.9bn from January through June.

Switzerland completes the top ten list. In June, the country received German electro goods with a value of €719m (+4.1%) and €4.2bn (+5.3%) in the first half of 2023.
